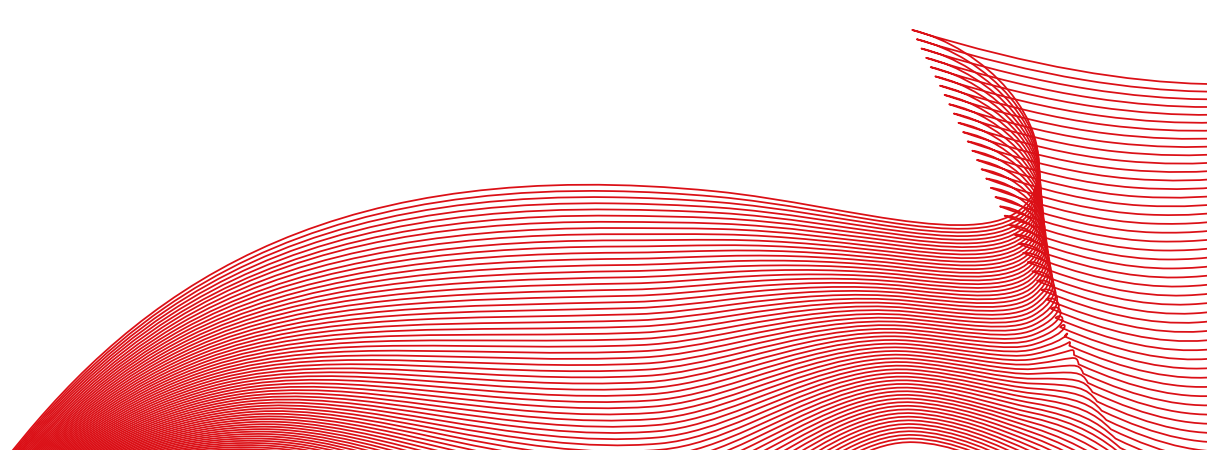
## Strength in numbers

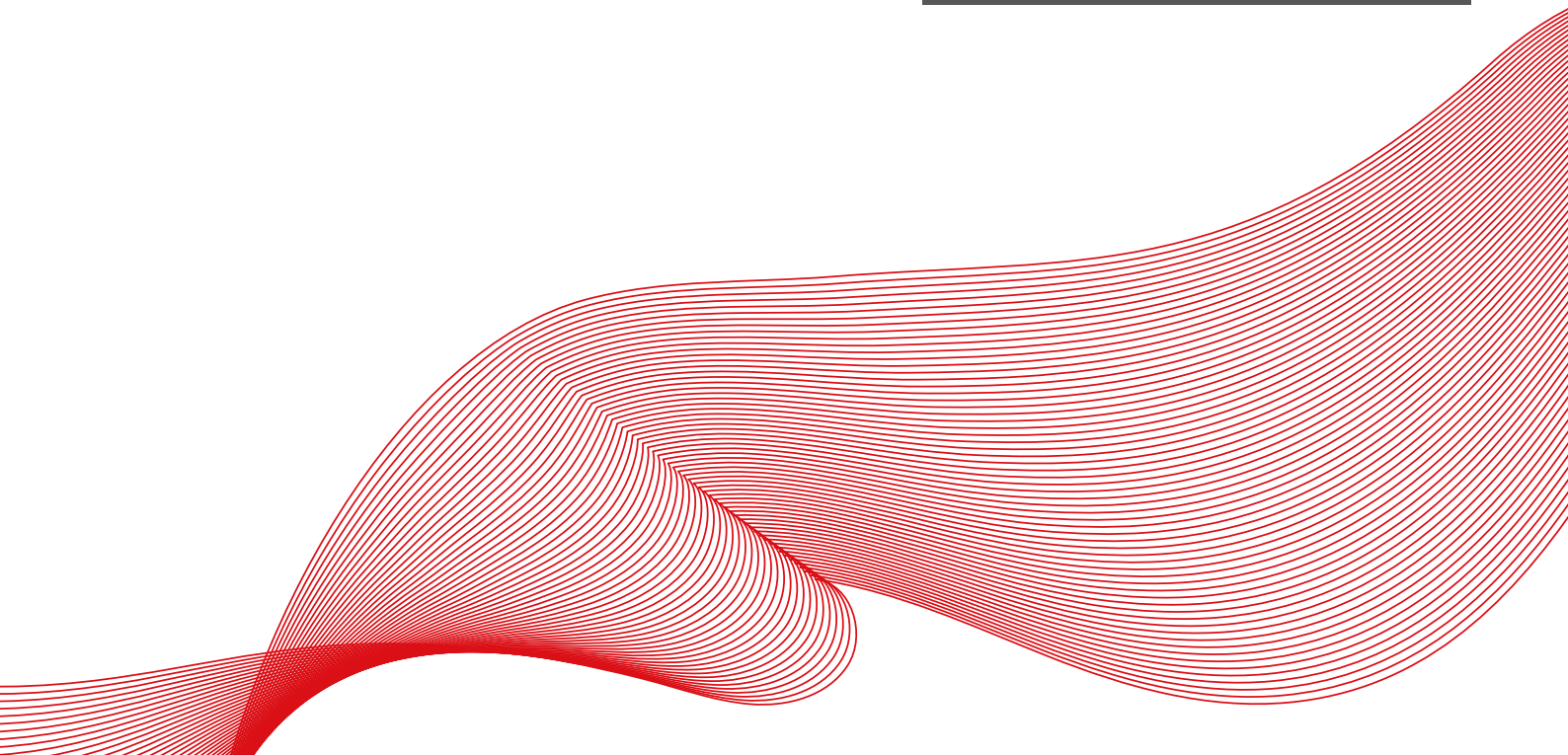
