The formation of the new leadership team comes shortly after Simon Beale became CEO, with James Illingworth becoming Chief Underwriting Officer and Martyn Rodden Chief Risk Officer.

The hires demonstrate our ability to attract leading industry talent and their wealth of experience and proven ability in successfully implementing change will be invaluable as we embark on an exciting new chapter in our history.
